As water becomes an ever-increasing limited resource in times of drought, the question of who owns it, and how much they can use, is hotly debated. Since 2010 when he was appointed as district judge, Judge Wildman has been instrumental in the assessment and adjudication of Idaho's water rights, and that work continues today. Professor Hedden-Nicely earned both a law degree and a master's degree in water resources and focuses his work at the University of Idaho on climate change and the impact on water rights. Establishing mechanisms to account for future environmental change has been a focus of his research.
