GENERAL ORDER NO. 434

Given the untimely passing of the Honorable Joseph M. Meier on November 22, 2023; and the necessity to assign responsibility for the cases pending and to be filed in this District;

NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

1. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, pending on November 30, 2023, and previously assigned to Chief Judge Joseph M. Meier with the designation JMM, EXCEPT those cases listed in Exhibit A, shall be and are hereby assigned to Chief Judge Hillen for all purposes and proceedings. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, pending on November 30, 2023, and assigned to Chief Judge Hillen or an active bankruptcy judge temporarily assigned to the District shall remain with the previously assigned judge.
2. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, that are listed in Exhibit A, shall be assigned to an active bankruptcy judge temporarily assigned to this District.
3. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, EXCEPT those bankruptcy cases and adversary proceedings where J. Ford Elsaesser is a party, attorney, or trustee, to be filed with this Court on or after November 30, 2023, shall be assigned to Chief Judge Hillen for all purposes and proceedings.

4. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, where J. Ford Elsaesser is a party, attorney, or trustee, filed with this Court on or after November 30, 2023, shall be assigned to an active bankruptcy judge temporarily assigned to this District.
